### 1. OPENING OF THE MEETING

The third meeting of the Economics Committee will be opened by its Chairman, H.E. Mr. Luis Valverde (Ecuador).

### 2. ADOPTION OF AGENDA

The Economics Committee will consider the draft agenda contained in this document as a basis for adopting its agenda.

### 3. THE WORLD COCOA ECONOMY: PRESENT AND FUTURE

The Secretariat will present a comprehensive overview of the current market situation and prospects for the world cocoa economy for the next five years, with reference to document EC/3/2.

### 4. REPORT OF THE 21<sup>ST</sup> MEETING OF THE EXPERT WORKING GROUP ON STOCKS

The Committee will receive a report on the twenty-first meeting of the Expert Working Group on Stocks which took place on 24 January 2014 at ICCO offices in London, with reference to document EWG/S/21/2.

### 5. IMPORT TARIFFS APPLIED IN COCOA TRADE

Following the presentation delivered at the second meeting of the Committee on Import Tariffs and Non-Tariff Measures applied in Cocoa Trade, the Committee will receive a presentation on import tariffs applied on cocoa beans and cocoa semi-finished products by all World Trade Organization (WTO) Member countries, contained in document EC/2/3/Add.1.

### 6. ECONOMIC STUDIES ON SELECTED TOPICS

- Determinants of cocoa prices and income of farmers;
- Value chain analysis: costs of production and value addition from the cocoa bean to the chocolate bar;
- Study on the provision of services to farmers through farmers' organizations and other modalities;
- Opportunities and constraints for cocoa processing in origin countries;
- Study on modalities for the establishment of a cocoa sustainability fund; and
- Optimizing and rationalizing the use of fertilizers and pesticides by cocoa farmers

The Secretariat will present possible studies on the above mentioned topics, with reference to document EC/3/3.

**7. ICCO/CABI/STDF PROJECT ON “COCOASAFE: CAPACITY BUILDING AND KNOWLEDGE SHARING IN SPS IN COCOA IN SOUTH EAST ASIA”: REPORT ON THE INCEPTION WORKSHOP**

The Committee will receive an oral report on the outcome of the Inception Workshop of the ICCO/CABI/STDF project on “CocoaSafe: Capacity Building and Knowledge Sharing in SPS in Cocoa in South East Asia”, which took place in Kuala Lumpur, Malaysia in November 2013.
