DEFINITIONS

WHO-IPCS HAS DEFINED AN ENDOCRINE DISRUPTOR (ED) AS "AN EXOGENOUS SUBSTANCE OR MIXTURE THAT ALTERS FUNCTION(S) OF THE ENDOCRINE SYSTEM AND CONSEQUENTLY CAUSES ADVERSE HEALTH EFFECTS IN AN INTACT ORGANISM, OR ITS PROGENY, OR (SUB) POPULATIONS".

HAZARD & RISK


HAZARD IS THE PROPERTY OF AN AGENT (CHEMICAL, PESTICIDE, ETC.), THAT HAS THE POTENTIAL TO CAUSE HARM

RISK IS THE PROBABILITY OF HARM TO OCCUR AS A FUNCTION OF A HAZARD AND THE LIKELIHOOD TO BE EXPOSED TO THE HAZARD

RISK = F (HAZARD X EXPOSURE)




