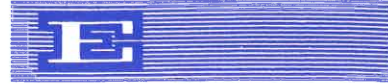

1. OPENING OF THE MEETING

The fifth meeting of the Economics Committee will be opened by its Chairman, Mr. Henk de Jong (The Netherlands).

2. ADOPTION OF AGENDA

The Economics Committee will consider the draft agenda contained in this document as a basis for adopting its agenda.

3. THE WORLD COCOA ECONOMY: PRESENT AND FUTURE

The Secretariat will present a comprehensive overview of the current market situation and prospects for the world cocoa economy for the next five years, with reference to document EC/5/2.

4. REPORT OF THE 22ND MEETING OF THE EXPERT WORKING GROUP ON STOCKS

The Committee will receive a report on the twenty-second meeting of the Expert Working Group on Stocks which took place on 23 January 2015 at ICCO offices in London, with reference to document EWG/S/22/2.

5. CAPACITY BUILDING

The Secretariat will report on the plans underway to hold an International seminar on the Preparation and Analysis of Cocoa Development Projects which will take place from 9-12 June 2015 at The Holiday Inn Hotel in Accra, at the kind invitation of the Government of Ghana.

The Committee will also be updated on the arrangements for a Seminar on cocoa terminal markets and econometric modelling of the cocoa market, for the Asian region, which is planned for 3-7 August 2015 in Bali, at the kind invitation of the Government of Indonesia.

6. PROGRESS REPORT ON PROJECTS

The Secretariat will report on cocoa development projects supervised by the ICCO, with reference to document EC/5/3.

7. THE COCOA MARKETING SYSTEM IN CÔTE D'IVOIRE

The *Conseil du Café-Cacao* (CCC) will make a presentation on the results of the reform of the cocoa marketing system in Côte d'Ivoire, with a forward auction system and a minimum price paid to cocoa farmers.

8. CONFERENCE ON THE TRENDS AND FUTURE PROSPECTS FOR THE SUPPLY AND DEMAND OF COCOA

The Committee will review the draft programme of the one-day Conference on the Trends and Future Prospects for the Supply and Demand of cocoa, with reference to EC/5/4. The Conference is scheduled to take place in London on Tuesday, 22 September 2015, during the week of the 92nd regular session of the Council and its subsidiary bodies, including the Consultative Board on the World Cocoa Economy, which are being held from 21-25 September 2015.

The Committee will review progress in the implementation of the Organization's work programme for the 2014/2015 cocoa year, with reference to document EC/5/5.
